NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2019 AND 2018

1. THE ORGANIZATION

Vesta Community Housing Development Board, Inc. (the Organization) purchases and rehabilitates buildings that are then rented to various community service programs or low-income tenants. Substantially all of the Organization's properties are located in New York State.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States.

Change in Accounting Principle

ASU 2014-09, Revenue from Contracts with Customers

In May 2014, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) 2014-09, *Revenue from Contracts with Customers*, and has subsequently issued supplemental and/or clarifying ASUs (collectively "ASC 606"). ASC 606 outlines a five-step framework that supersedes the principles for recognizing revenue and eliminates industry specific guidance. The core principle of the guidance in ASC 606 is that an entity should recognize revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods and services. In addition, ASC 606 revises current disclosure requirements in an effort to help financial statement users better understand the nature, amount, timing, and uncertainty of revenue that is recognized. The Organization adopted ASC 606 as of January 1, 2019 using a modified retrospective approach. There was no effect on total net assets or changes in net assets.

ASU 2018-08, Clarifying the Scope and the Accounting Guidance for Contributions Received and Contributions Made

In June 2018, the Financial Accounting Standards Board (FASB) issued ASU 2018-08, *Clarifying the Scope and the Accounting Guidance for Contributions Received and Contributions Made*. ASU 2018-08 clarifies the determination of whether a grant or contract is a contribution or an exchange transaction subject to other guidance. Changes resulting from the adoption of ASU 2018-08 were made on a modified prospective basis during the year of adoption and therefore had no effect on the financial position or results of operations for the year ended December 31, 2018. There was no effect from the change in accounting principle on the financial position or results of operations for the year ended December 31, 2019.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Cash

The Organization maintains cash in bank demand accounts which, at times, may exceed federally insured limits. The Organization has not experienced any losses in these accounts and believes it is not exposed to any significant credit risk with respect to cash.

Pledges Receivable

Pledges Receivables are reported as restricted support if they are received with donor stipulations that limit the use of the donated assets. Contributions that are restricted by the donor are reported as increases in net assets without donor restrictions if the restrictions expire or are met in the same year in which the contributions are recognized. When a restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statement of activities as net assets released from restrictions. There was no allowance for uncollectible pledges or discount as of December 31, 2019. The pledges receivable of \$200,000 as of December 31, 2019, is expected to be received within one year.

Loans Receivable – Due from Affiliates

Loans receivable are stated at unpaid principal balances, less impairment for loan losses. Management periodically evaluates each loan for collectability based on inherent collection risks and adverse situations that may affect the borrower's ability to repay. The loans are non-interest bearing and are expected to be short-term in nature, unless otherwise arranged. After all collection efforts are exhausted, amounts deemed uncollectible based upon assessment of the debtor's financial condition are written off. No impairment reserve was recorded as of December 31, 2019 and 2018.

Rental Property and Equipment

Rental property and equipment are stated at cost less accumulated depreciation. All significant assets with an estimated useful life of more than one year are capitalized. Depreciation is computed using the straight-line method with estimated useful lives ranging from five to forty years.

Loan Acquisition Costs

Loan acquisition costs represent costs incurred to obtain long-term financing. These costs are recognized as interest expense on the organization's financial statements on a straight-line basis over the term of the related debt that resides on this entity.

Financial Reporting

The Organization reports its net assets and changes therein in the following classifications:

- Net assets without donor restrictions include operating resources which are available for the support of the Organization's operating activities.
- Net assets with donor restrictions are those net assets that are restricted by donors for specific purposes or whose principal may not be expended. As of December 31, 2019 and 2018, there are no net assets with donor restrictions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Rental Income

The Organization is the lessor of real property, mostly with affiliated companies. The Organization has agreement with lessees that provide for payments at amount for their established charges for each rental property. Revenue is recognized when the Organization satisfies its performance obligations under rental agreements by transferring services to the lessees. The Organization's performance obligations are to provide premises to lessees for their residence. The transaction price is based on established charges for services provided determined using the output method. Each month, the performance obligation is satisfied as the benefit of the services are consumed and rental fees from affiliated companies and other individuals are recorded.

Because performance obligations are met on a monthly basis, there are no monthly fees allocated to performance obligations that are unsatisfied or partially unsatisfied at the end of the reporting period. Rental fees are charged and collected on a monthly basis. The Organization reviews each rental agreement to determine estimated uncollectable accounts due from lessees, and records implicit price concessions as a direct reduction to the Organization's revenues. At December 31, 2019, no such implicit price concessions were considered necessary.

Income Taxes

The Organization is a not-for-profit corporation organized pursuant to Section 501(c)(3) of the Internal Revenue Code. The Organization has also been classified by the Internal Revenue Service as an entity that is not a private foundation.

3. LIQUIDITY

The Organization is substantially supported by revenue generated by its operations. In addition, some support is received from government grants and donors. The following reflects the Organization's financial assets as of the statement of financial position date, reduced by amounts not available for general use because of contractual or donor-imposed restrictions within one year of the statement of financial position date.

3. LIQUIDITY (Continued)

The Organization's financial assets include cash, and pledges receivables- current portion. The Organization's ability to meet its cash needs is highly dependent on timely collection of its accounts receivable. The Organization's accounts receivables are due primarily from donors. The Organization has designed procedures to collect from these payers as quickly as possible. However, timeliness of these payments can sometimes be difficult to predict. As part of the Organization's liquidity management, it has a policy to structure its financial assets to be available as its general expenditures, liabilities and other obligations come due. In addition, the Organization could also manage vendor relationships to extend payment terms where possible.

Generally, loans among affiliates are non-interest bearing, short-term in nature and repayment is expected within 12-24 months.

Lease Agreements

The Organization leases space to 820 River Street, Inc. and Altamont Program, Inc. under the terms of various lease agreements. See Note 7 for a summary of leases.

6. LONG-TERM DEBT

Mortgage Loan Agreements and Forbearance Agreement

During September 2014, an unrelated company purchased three mortgage loans originally with First Niagara Bank representing approximately \$2.3 million of debt. Shortly after purchasing these loans, the new mortgagor and the Organization entered into a forbearance agreement whereby interest will accrue, but there is no payment of principal or interest due until December 31, 2021 at which time the entire balance is due in full. The forbearance agreement requires the Organization and its affiliates to pay certain real estate taxes and utilities on the mortgaged properties during the forbearance period in order to be in compliance with the agreement. 40% of the net proceeds from sale of any real property owned by the Organization and its affiliate (820 River Street, Inc.) are to be applied to the outstanding principal amount from December 31, 2019 to the date that the indebtedness has been paid in full. Accrued interest on the mortgage payable was forgiven for both 2019 and 2018.
