NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2019 AND 2018

1. THE ORGANIZATION

820 River Street, Inc. (Organization) operates and maintains inpatient, outpatient, and counseling and evaluation programs that provide programs of care, service, rehabilitation, and treatment for persons afflicted with the illness of alcoholism, alcohol abuse, and substance abuse in various locations throughout New York State. The Organization operated the following programs during 2019 and/or 2018:

- Outpatient Clinics – Provide treatment and counseling for alcohol and substance abuse. The Organization operates two clinics as of December 31, 2019: Eleanor Young and Baywood. The outpatient clinic group also includes an Access program. Access provides relapse prevention to parolees.
- Halfway Houses – Provide a structured living environment. The Organization operates three halfway houses located on Sixth Avenue in Troy, on Crandall Street in Glens Falls, and on Route 22 in Granville (closed in May 2018).
- Supportive Living Programs – Provide housing for rehabilitated clients. The Organization operates six supportive living programs. These programs are located on River Street and Second Avenue in Troy, on Lawrence Street in Glens Falls, on South Road in Queens, St. Joseph's in Albany and on Park Avenue in Utica (closed in January 2019).

Discontinued Operations

The Organization made strategic changes in 2013 through 2019 to discontinue the operations of several programs which had been generating substantial losses. As a result, the accompanying statements of activities reflect support, revenue and expenses from continuing operations and separately report losses from discontinued operations.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Change in Accounting Principle

ASU 2014-09, Revenue from Contracts with Customers

In May 2014, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) 2014-09, *Revenue from Contracts with Customers*, and has subsequently issued supplemental and/or clarifying ASUs (collectively "ASC 606"). ASC 606 outlines a five-step framework that supersedes the principles for recognizing revenue and eliminates industry specific guidance. The core principle of the guidance in ASC 606 is that an entity should recognize revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods and services. In addition, ASC 606 revises current disclosure requirements in an effort to help financial statement users better understand the nature, amount, timing, and uncertainty of revenue that is recognized. The Organization adopted ASC 606 as of January 1, 2019 using a modified retrospective approach. There was no effect on total net assets or changes in net assets.

ASU 2018-08, Clarifying the Scope and the Accounting Guidance for Contributions Received and Contributions Made

In June 2018, the Financial Accounting Standards Board (FASB) issued ASU 2018-08, *Clarifying the Scope and the Accounting Guidance for Contributions Received and Contributions Made*. ASU 2018-08 clarifies the determination of whether a grant or contract is a contribution or an exchange transaction subject to other guidance. Changes resulting from the adoption of ASU 2018-08 were made on a modified prospective basis during the year of adoption and therefore had no effect on the financial position or results of operations for the year ended December 31, 2018. There was no effect from the change in accounting principle on the financial position or results of operations for the year ended December 31, 2019.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Cash

The Organization maintains its cash in bank demand accounts which, at times, may exceed federally insured limits. The Organization has not experienced any losses in these accounts and believes it is not exposed to any significant credit risk with respect to cash.

Accounts Receivable, Grants Receivable and Credit Policies

Accounts receivable include uncollateralized obligations primarily from Medicaid and various counties' Departments of Social Services. These obligations are due under customary credit terms. Accounts receivable from Medicaid are generally billed on a weekly basis and are due within 30-45 days. Accounts receivable from the various Departments of Social Services are generally billed at the beginning of each month requiring payment within 30 days. The carrying amount of accounts receivable is reduced by a valuation that reflects management's best estimate of amounts that will not be collected. Management reviews all accounts receivable balances and estimates the portion of the balance that will not be collected based on historical collection percentages. After all collection efforts have been exhausted, the account is written off. For accounts receivable subsequent to the adoption of ASC 606, the estimated uncollectible amounts are generally considered implicit price concessions that are a direct reduction to accounts receivable.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Loans Receivable - Due from Affiliate

Loans receivable are stated at unpaid principal balances, less allowance for loan losses. Management periodically evaluates the loans for collectability based on inherent collection risks and adverse situations that may affect the borrower's ability to repay. All intercompany loans are non-interest bearing and are expected to be short-term in nature, unless otherwise arranged. After all collection efforts are exhausted, and amounts deemed uncollectible based upon assessment of the debtor's financial condition are written off.

Property and Equipment

Property and equipment are stated at cost less accumulated depreciation under the straight-line method, with estimated useful lives ranging from 5 to 35 years. Leasehold improvements are amortized over the shorter of the remaining term of the lease or the estimated useful life of the improvement. Significant assets with an estimated useful life of more than one year are capitalized. Depreciation expenses charged to operations are \$129,878 and \$121,725 for December 31, 2019 and 2018, respectively.

Due to Third Party Payors

Due to third party payors includes estimated amounts due to funding sources for regulatory audits (See Note 8) and settlements of prior year grant obligations (See Note 5).

Financial Reporting

The Organization reports its net assets and changes therein in the following classifications:

- Net assets without donor restrictions include operating resources which are available for the support of the Organization's operating activities.
- Net assets with donor restrictions are those net assets that are restricted by donors for specific purposes or whose principal may not be expended. As of December 31, 2019 and 2018, there are no net assets with donor restrictions.

Revenue - Client Fees

Outpatient Clinics

The clinics received a majority of their net client fees from Medicaid. Medicaid revenue is recognized at amounts that reflect the consideration to which they expect to be entitled in exchange for providing clinical services. These amounts are due from patients, third-party payors (including managed care payors and government programs) and others, and they include variable consideration for retroactive revenue adjustments due to settlement of audits, reviews and investigations. The Medicaid reimbursement rates have been determined utilizing a reimbursement methodology that requires periodic statistical data to be submitted by the Organization, which then affects its reimbursement rate currently and in the future. The Organization is typically paid for services at amounts that are negotiated with insurance companies or are set by the government. Revenue is recognized when the Organization satisfies their performance obligations under contracts by transferring services to patients at a point in time. The Organization's performance obligations are to provide clinical services. The transaction price is based on established charges for services provided determined using the output method. These rates are determined by allowable expenditures in rate setting periods.

The Organization has agreements with third-party payors that provide for payments at amounts different from their established charges. Payment arrangements include prospectively determined rates per procedure or visit, cost-based reimbursement, discounted charges, per diem payments and fee-for-service payments. The Organization recognizes clinical service revenue provided to patients who have third-party payor coverage on the basis of contractual rates for the services rendered, including estimated retroactive adjustments due to future audits, reviews, and investigations.

The Organization also bills private pay patients with the expectation of full collection at time of billing. However, a certain portion of the Organization's private pay patients will likely be unable or unwilling to pay for the services provided. Patients accounts are monitored for patients who are unwilling to pay for services provided.

There are various factors that can impact collection trends, such as changes in the economy, unemployment rates, the number of uninsured and underinsured patients, mix of third-party payors, and business practices related to collection efforts. These factors continuously change and can have an impact on collection trends and the estimation process. Subsequent changes to the estimate of the transaction price are generally recorded as adjustments to net clinic revenue in the period of the change. Estimates of implicit price concessions, if any, are determined based on historical collection experience with individual contracts. The Organization has a policy to write off amounts to bad debt expense when the account becomes greater than 120 days and all collection efforts are exhausted.

Retroactive adjustments are included in the recognition of clinical service revenue on an estimated basis in the period the related services are rendered and adjusted in future periods as adjustments become known or as years are no longer subject to such audits, reviews and investigations.

Settlements with third-party payors for retroactive revenue adjustments due to audits, reviews or investigations are considered variable consideration and are included in the determination of the estimated transaction price for providing clinical services using the most likely outcome method. These settlements are estimated based on the terms of the contractual agreement with the payor, correspondence from the payor and historical settlement activity, including an assessment to ensure that it is probable that a significant reversal in the amount of cumulative revenue recognized will not occur when the uncertainty associated with the retroactive adjustment is subsequently resolved. Estimated settlements are adjusted in future periods as adjustments become known (that is, as new information becomes available), or as years are settled or are no longer subject to such audits, reviews and investigations.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Revenue - Client Fees (Continued)

Halfway Houses and Supportive Living

The Organization recognizes revenue in the period in which they satisfy performance obligations under contracts by providing residential services. The Organization recognizes revenue for performance obligations satisfied at a point in time. The Organization's performance obligation includes providing residential services. For these programs, the Organization receives a majority of its client fees from local Department of Social Services agencies at a rate established by New York State. If a client is employed, they are considered self-pay and are charged a weekly amount based on a sliding fee scale.

Prior to the adoption of ASC 606, the Organization provided an allowance for doubtful accounts based on review of the individual's ability to pay for services provided. Amounts due from third party payors or private pay individuals were written off when they were determined to be uncollectible.

After adoption of ASC 606, the Organization reviews individual contracts at the time of performance, in order to determine estimated uncollectable accounts due from third party payors or private pay individuals and records these implicit price concessions as a direct reduction to revenue. Estimates of implicit price concessions are determined based on historical collection experience using a portfolio approach as a practical expedient to account for the contracts as a collective group. Based on this, the Organization determined that there is no implicit price concessions for the year ended December 31, 2019.

Contributed Services

The Organization recognized contributed services from an individual who donated services as chief executive officer of the Organization and an individual who donated services as grant writer to the Organization. These financial statements include contributed services revenue and a corresponding expense to properly reflect the value of these donated services based upon an estimate of their fair value.

Allocation of Certain Expenses

The costs of providing various programs and supporting services have been summarized on a functional basis in the statement of functional expenses. Accordingly, certain costs have been allocated amongst the programs and supporting services benefited. The expenses with the most significant allocations include certain salaries, fringe benefits, maintenance and property related costs, and agency administrative costs. All expenses are allocated in line with acceptable allocation methodologies as described by government funding sources. In addition, all attempts are made to direct charge expenses before allocations are made.

Indirect salary allocations are recorded based on hours charged by program in the payroll system or time studies that are submitted quarterly by applicable personnel. Fringe benefit costs are allocated based on total salaries to each program or cost center. Maintenance and property related costs are allocated using square footage of each program or cost center. Lastly, agency administrative costs are allocated using the ratio value method, which calculates a percentage for each program based on the total costs of the program compared to the Organization's total expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Performance Indicator

The accompanying statements of activities reflect operating income (loss) and non-operating income (expense). Transactions deemed by management to be ongoing, major and central to operations are reported as operating revenue and expenses. Peripheral, incidental and non-recurring transactions are reported as non-operating revenue or expense.

Income Taxes

The Organization is a not-for-profit corporation organized pursuant to Section 501(c)(3) of the Internal Revenue Code. The Organization has also been classified by the Internal Revenue Service as an entity that is not a private foundation.

3. LIQUIDITY

The Organization is substantially supported by revenue generated by its operations. In addition, some support is received from government grants and donors. The following reflects the Organization's financial assets as of the statement of financial position date, reduced by amounts not available for general use because of contractual or donor-imposed restrictions within one year of the statement of financial position date.

The Organization's financial assets include cash and accounts receivables. The Organization's ability to meet its cash needs is highly dependent on timely collection of its accounts receivable. The Organization's accounts receivables are due primarily from government funders and third-party payers including Medicaid. Many of these arrangements require the Organization to incur costs in advance and then bill for reimbursements after the cash outlay has been made. The Organization has designed procedures to collect from these payers as quickly as possible. However, timeliness of these payments can sometimes be difficult to predict. As part of the Organization's liquidity management, it has a policy to structure its financial assets to be available as its general expenditures, liabilities and other obligations come due. In addition, the Organization could also manage vendor relationships to extend payment terms where possible.

5. OASAS ALTAMONT HOUSE GRANT

During 2013, the Organization received a capital improvement grant of \$6,600,000 for renovation, construction, and restoration of the Altamont House building. OASAS advanced \$900,000 for roof repair and preliminary drawings prepared by the New York State Dormitory Authority. In December 2014, OASAS cancelled the grant. The Organization acknowledged receipt of \$647,441 for roof repair and preliminary drawings and returned the balance to OASAS. The Organization is disputing \$347,441 for the preliminary drawings. In December 2019, the dispute was settled and the current lien balance as of December 31, 2019 is approximately \$264,500.

6. RELATED PARTY TRANSACTIONS

The Organization is affiliated with certain other nonprofit organizations as a result of having one or more individuals who serve on the board of directors of each organization. Transactions with affiliated organizations primarily include the rental of facilities (Note 7), the sharing of employees and services, and short-term loans and advances. Intercompany loans and advances are unsecured and intended to be short-term in nature (i.e. 1-2 years) and are non-interest bearing.

The Organization accrued interest of \$9,277 for both 2019 and 2018, respectively, in connection with the loans payable to Father Peter G. Young. Father Young has agreed to forgive the interest for 2019 and 2018, and has agreed to postpone repayment of these loans until 2021.

7. OPERATING LEASE

Most of the Organization's programs (unless specifically noted otherwise) lease their operating premises from Vesta. Monthly rents related to these leases are on a month-to-month basis ranging from \$500 to \$2,900. Total rent expense for 2019 and 2018, were \$190,387 and \$202,158 (including \$6,000 in-kind), respectively.

8. COMMITMENTS AND CONTINGENCIES

Compliance with Funding Sources

The Organization receives funding from New York State Office of Alcoholism and Substance Abuse Services (OASAS) and Medicaid funding for its clinic and outpatient programs. Under the terms of these programs, the Organization is subject to licensing and audit requirements by the funding source.

As part of an audit commenced several years ago by the New York State Justice Center in conjunction with OASAS and other state agencies, several demands were made by the agencies and are contested by the Organization. In a letter dated January 18, 2017, OASAS stated they will 'terminate all OASAS contracts and funding with 820 River Street, Inc.' due to the Organization not meeting their demands.

Management and the Board of Directors of 820 River Street, Inc. strongly opposed the planned OASAS actions and they filed a legal action to prevent OASAS from terminating their funding.

The Organization and OASAS presented their arguments in court during 2017 and 2018. In December 2019, a final decision was issued by New York State Supreme Court. Amount owed to the Organization for services provided from 2014 through April 30, 2017 was net against lien balances (see note 5) in amount of approximately \$264,000 on the statement of financial position for the year ended December 31, 2019.

8. COMMITMENTS AND CONTINGENCIES (Continued)

Litigation

As of December 31, 2019, the Organization was involved in certain litigation matters against the Organization that occurred in the ordinary course of business. At this time, there are no issues that are expected to have a significant financial impact on the Organization.

Medicaid Revenue

As stated in Note 2, Medicaid revenue is recognized when earned based upon tentative rates that are subject to audit and retroactive adjustment. The Medicaid cost report for 2019 has not yet been submitted to OASAS, and has not been reviewed or audited. The 2018 cost reports have been reviewed, but have not been audited by OASAS. The final outcome of cost report reviews or potential audits, if any, cannot be determined at this time and, as a result, there is no provision in these financial statements for any future settlements.

9. MANAGEMENT'S PLANS

Over the past 3 years, 820 River Street, Inc. has experienced nearly \$1 million in operating losses due to the Organization providing deficit funded programs without corresponding revenues previously provided by New York State Office of Addiction Services and Support (OASAS). Consequently, the Organization's net assets have steadily declined.

In response, the following financial strategies will be used in 2020 and subsequent years to help balance the budgets:

1. We obtained a PPP loan in the amount of \$394,820 in April 2020. It is anticipated we will get complete forgiveness of this loan later in 2020.
2. Cost saving measures are planned at several locations to reduce program losses by approximately \$250,000 annually. Cost saving measures include restructuring of program expenses and staffing support levels to more closely match program revenues with direct costs including those associated with the 2 remaining OASAS deficit funded locations.
3. The current real estate tax certiorari appeal with the Town of Guilderland, which we believe will be decided in our favor, will reduce property tax expenses by \$70,000 annually. It may also result in obtaining a refund for prior year property taxes of \$100,000.
4. The Organization has covered some of the operating losses to date with a \$450,000 donation from The Father Peter G. Young, Jr. Foundation. The Foundation should generate sufficient donations to support at least \$150,000 contribution to 820 River Street Inc. in 2020. When times return to normal (post-COVID) we can resume strategic planning for additional fund raising efforts from the Peter G. Young Foundation.
5. In January 2020, the NYS Supreme Court ordered OASAS to reimburse \$230,000 for deficit funded program services for the period January – April 2017.

10. DISCONTINUED OPERATIONS

As explained in Note 1, due to certain operational and financial deficiencies, the Organization's Altamont House inpatient program, Brooklyn Intensive Residential program and Sutphin Outpatient Clinic closed during 2014, Granville Halfway House closed during 2018 and Utica Supportive Living closed during 2019. The total expenses for the year ended December 31, 2019 and 2018 included \$320,826 and \$323,146 of expenses, respectively, related to the Altamont House program, Intensive Residential program, Granville Halfway House and Utica Supportive Living (2019 only) that were reported as a component of the loss from discontinued operations in the accompanying statements of activities.

11. SUBSEQUENT EVENTS

In May 2020, the Organization entered into an unsecured promissory note payable to a bank in the amount of \$394,820. This note was entered into by the Organization as part of the U.S. Small Business Administration's Paycheck Protection Program (PPP) under the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The PPP provides for this borrowing, or a portion of the borrowing, to be forgiven to the extent the Organization meets defined requirements related to expenditure of the funds and management of the Organization's personnel complement. Through the date the financial statements were available to be issued, the Organization is unable to determine the amount of potential loan forgiveness. Management believes these notes will be forgiven based on the stipulations within the loan agreements. If no forgiveness is granted, the terms of this agreement require the Organization to make monthly principal payments, including interest at 1%, from December 2020 through May 2022.

The United States is presently in the midst of a national health emergency related to a virus, commonly known as Novel Coronavirus (COVID-19). The overall consequences of COVID – 19 on a national, regional and local level are unknown, but it has the potential to result in a significant economic impact. The impact of this situation on the Organization and its future results and financial position is not presently determinable.

Subsequent events have been evaluated through August 6, 2020, which is the date the financial statements were available to be issued.
